STEP 1: PROGRAM QUALIFICATIONS - All forms are subject to approval.

Please certify that the following information is accurate to the best of your knowledge before continuing to Step 2 of the Application. In addition, please check each box to confirm you understand and fulfill each requirement of the Property Tax Rebate Program.

I (We) have held legal or equitable title to Residential Real Estate continuously between 01-01-2021 and 12-31-21.

I (We) or tenants of the property have no past due bills (utility bill), tickets, or violations and no outstanding balances with the Village.

I (We) understand that if my property is a rental property, the owners are the only ones who qualify for the property tax rebate.

I (We) have paid all of the 2020 Real Estate Taxes either directly or through the mortgage lender, and there is no other prior or subsequent owner who has paid such taxes in whole or in part.

I (We) pay taxes to the Village of Montgomery and confirm that 2020 property and special assessment taxes are paid. This program excludes Village of Montgomery utility-only customers such as Boulder Hill residents, who do not pay taxes to the Village as part of their annual assessment.

I (We) acknowledge the property owner's responsibility to report this rebate to the IRS as part of the annual income tax filing.

If I (we) knowingly falsify information on this application, the Village has the right to seek a refund and take any legal remedies.
