- I (We) understand this program excludes Village of Montgomery utility-only customers, such as Boulder Hill residents, who do not pay taxes to the Village as part of their annual assessment.

- If I (we) knowingly falsify information on this application, the Village has the right to seek a refund and take any legal remedies.
